## **Real Media General Contest Rules**

These rules apply to all contests conducted by Real Media, Inc. d/b/a WRAR-FM, WNNT-FM unless otherwise set forth in specific contest rules for a particular contest. Particular contest rules will be available at the studios at 156 Prince Street, Tappahannock VA 22560.

- Anytime you call the WRAR-FM/WNNT-FM Studios you assume that your call will be broadcast or recorded and you grant us permission to broadcast the call or record it for later broadcast.
- As a winner of a WRAR-FM and/or WNNT-FM contest your voice, name and/or picture may be used for promotional, broadcast or internet purposes.
- NO PURCHASE NECESSARY. Only 1 winner per household, per contest.
- Please wait 2 weeks after winning before playing again unless otherwise stated in specific contest rules.
- You must be 18 or older to play unless otherwise stated in specific contest rules.
- Prizes must be claimed within 30 days, after which prizes are forfeited and become the property of Real Media, Inc.
- Prizes must be claimed at the WRAR-FM/WNNT-FM Studios at 156 Prince Street, Tappahannock VA 22560 during regular business hours, Monday thru Friday 8:30am to 4:30pm unless otherwise stated in specific contest rules. The office is closed weekends and holidays. Photo identification is required to claim a prize.
